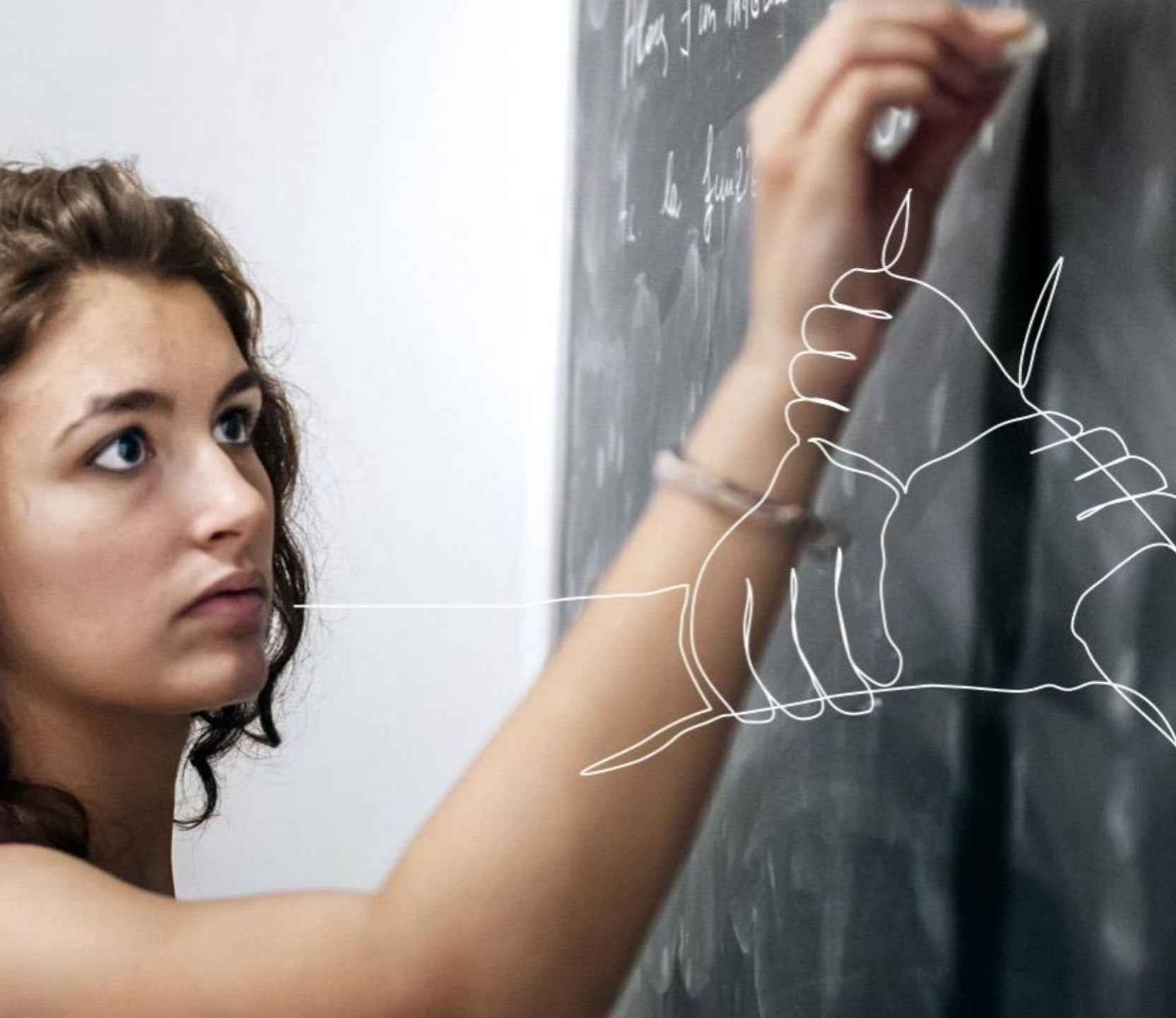

WP2

Mapping of research capacities and outputs per SRA and SDG done, but putting the information into practice remains a challenge.

WP3

Good tools created, fully exploiting them remains a challenge.

Work ahead:

- ✓ Network of OS Ambassadors
- ✓ Training hub
- ✓ Common EELISA mechanisms to reward OS

WP4

Development of the **online catalogue under preparation:** tender closed taking into account interoperability and update.

Finding **common rules of access** remains a challenge due to heterogeneity. Exploring the principle "Any EELISA researcher or academic [...] shall be considered as an internal user of this piece of equipment".

WP5

Open calls facilitate the creation of connections. Some challenges identified:

- ✓ Unattractive budget compared to other calls.
- ✓ Researchers with already existing heavy workloads.
- ✓ Researchers with already existing networks.

Work ahead:

- ✓ 2nd call for workshops
- ✓ Networking platform up&running

WP6

Development of a holistic outreach and management strategy for external stakeholder, which encompasses all dimension of the Alliance, still pending.

1st EELISA industrial chair (pending).

WP7

Many innovation & entrepr. Initiatives already open, more to be open.

2nd EELISA Prototype Contest and an EELISA Entrepreneurship Bootcamp

WP7 / WP6

Second round of public talks ongoing. Attracting public remains a challenge due to high amount of events.
